

Sponsorship of Scientific and Educational Events organised by EFMC National Adhering Organisations

The organizers of scientific events or post-graduate educational activities related to Medicinal Chemistry or Chemical Biology may apply for official EFMC Sponsorship by formally asking for it to the EFMC Secretariat (preferably by e-mail).

The application must include information on:

- Organizers
- Dates and place
- Program
- Registration conditions and fees

The sponsorship is approved by the Executive Committee, depending on the following conditions:

Physical Events

- Minimum duration of one full day.
- Relevance and quality of the program.
- International participation and the use of the English language.
- Application received at least 3 months prior to the event.

Virtual Events

- Minimum duration of 2,5 hours.
- Relevance and quality of the program, composed of at least three speakers.
- International participation and the use of the English language.
- Application received at least 1 months prior to the event.

Sponsorship will not be granted to events overlapping with EFMC events nor other EFMC sponsored events.

The benefits of the EFMC sponsorship for the event are:

- **Branding:**
 - o Right to visualize it (by the EFMC logo and the statement "EFMC Sponsored Event") in all the publications related with the event.
- **Promotion:**
 - o Dissemination through the EFMC website & event calendar.
 - o Listing of the event in multiple issues of the EFMC Newsletter: MedChemBioWatch.
 - o Dedicated article in one EFMC mailing related to the EFMC Sponsored Event.
 - o Opportunity to write a short report of the event, to be published in the EFMC Newsletter: MedChemBioWatch.
